Recreation groups refer to those sports and recreation groups that are not traditional or mainstream yet are important in providing a diverse range of recreational opportunities for the broader community. Recreation groups can also include sport and recreation activities that provide for mixed gender teams.

Additional Fee - Turf wickets (SFG section 5.3.2)

Presently, Council fully maintains three turf Sports Fields within the municipality during the summer season. The sports fields are Box Hill City Oval, Mont Albert Reserve and Surrey Park South West.

Council will subsidise 75% the cost of preparation of one turf wicket table and one practice table for each Tenant Club in competitions requiring such standard Facilities. Within the practice wicket table, two practice wickets will be prepared for each Tenant Club. On the match wicket area, wickets will be prepared for fixtured games only. Any further wicket areas will be prepared at the expense of the Tenant Club.

For this reason an additional fee of **\$16,663** (includes GST) will be charged to Tenant Clubs that are allocated a turf cricket pitch during summer. This fee will increase each year as determined by Council in the annual budget process. One half of this fee will be invoiced in November and the balance of the turf wicket fee will be invoiced in February.

Council will prepare match and practice wickets for the semi finals of home and away competition at no charge to the Tenant Clubs if they involve Whitehorse based clubs. For Grand Finals, final match fees will be applicable as indicated in section 4.3 and turf wicket preparation fees will also apply. Fees will be charged to the cricket association. The following allocation conditions will also apply:

- Country Week will be considered a fixtured event; therefore no additional fee will be required.
- For visiting internationals, state teams or exhibition matches a fee of **\$252.80** including GST will apply for centre wicket preparation. The cost will be **\$480** including GST if practice wickets are also required.
- These fees will increase each year as determined by Council in the annual budget process.

2. Number of people per session

The number of participants per group per session shall be no more than 20 and no less than 1. This number is to be assessed by Council, and dependent on the site.

3. Number of sessions per week per site

This will be assessed by Council on a case by case basis due to the varying needs of each Council open space.

4. Hours of operation

Not before 6:00am and not after 8:30pm.

Hours of operation will be assessed by Council and approved subject to the site.

Sports floodlights are not permitted for use; battery-powered lights may be approved and must be supplied by the trainer for use outside of daylight hours. Trainers must apply to Council in writing prior to using battery powered lights.

1. APPLICATION

Simpson Park Community Facility is owned by the Whitehorse City Council. All bookings are to be made on the official application form and all changes must be made in writing. The hire period must include time for set up and pack up.

The City of Whitehorse reserves the right to refuse any application for hire of the Simpson Park Community Facility from any individual or organisation at its discretion.

Confirmation of the booking will be made following receipt of a completed Application Form.

PLEASE NOTE:

No person or entity, other than the party named in the Application Form, may use or occupy the Simpson Park Community Facility without the express written permission of Council.

2. FEES AND CHARGES

Casual Community Use Fees – are set by Council, please refer to the Leisure and Recreation Services Department on 9262 6371. All accounts are payable within 30 days.

The fees and charges for the hire of the Simpson Park Community Facility are **\$26.70 per hour** (incl. GST) as at 1 April 2026. These fees will increase each year as determined by Council in the annual budget process. Council reserves the right to alter any existing hire charges or fix special charges for the hiring of the Facility for any period.

Seasonal Use Fees– Simpson Park Community Facility has been classified as a category C pavilion.
