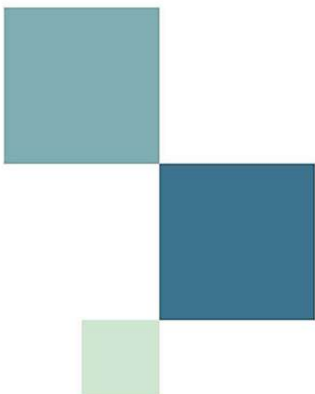

INTRODUCTION

The Register of Public Roads is referenced in Council's Road Management Plan.

The Register is prepared in accordance with Section 17 and Schedule 1 of the Road Management Act 2004 and is a register of those roads which Council has decided are reasonably required for general public use.

The road and pathway hierarchy is defined in Council's Road Management Plan.

Arterial roads, highways and freeways are managed by the State Government through Transport Victoria (VicRoads) and are not included in Council's Register.

Unconstructed lanes and right-of-ways (R.O.W) have generally not been included in this road register. There are a number of roads, shown as roads on plans of subdivision and used by the public as roads, which are defined as 'unconstructed' roads. These roads are not included in the register. Council has a policy to construct these roads to approved standards, refer to item 12.1.7 Council meeting of 5 October 1998. Once constructed, these roads will be included in the roads register.

LIST OF REGISTERS

The Register contains a list of the public roads within Whitehorse that Council has a statutory requirement to inspect, maintain and repair in accordance with its Road Management Plan.

- **APPENDIX A - PUBLIC ROAD REGISTER - ROADS**

This register lists the constructed roads and council access roads that Council's responsibility under the Road Management Plan.

- **APPENDIX B - PUBLIC ROAD REGISTER - LANEWAYS**

This register lists the constructed laneways that are Council's responsibility under the Road Management Plan.

- **APPENDIX C - ANCILLARY AREAS - CARPARKS**

This register lists the constructed carparks that are Council's responsibility under the Road Management Plan.

- **APPENDIX D – PUBLIC ROAD REGISTER – FOOTPATHS**

This register lists the constructed footpaths that are Council's responsibility under the Road Management Plan.

- **APPENDIX E – PUBLIC ROAD REGISTER – SHARED AND BICYCLE PATHWAYS**

This register lists the constructed shared and bicycle pathways that Council's responsibility under the Road Management Plan.
