## Voluntary Foster Carer Registration Information

Under the *Domestic Animals Act 1994* (DA Act), foster carers must register all foster animals (over three months of age) housed at their premises with their local council, even if the animal is just in their temporary care.

### *What is the voluntary foster carer registration scheme (FCRS)?*

Individual foster carers may apply to their local council to be a registered foster carer under the voluntary FCRS, with registration valid for one year. In accordance with section 68H of the DA Act, council may charge a fee for registration. Voluntarily registered foster carers will receive:

- a reduced registration rate of approximately \$8 for each dog they foster during the first 12 months the dog is in their care (rate valid from 10 April 2024 to 9 April 2025)
- a reduced registration rate of approximately \$8 for each cat they foster during the first 12 months the cat is in their care (rate valid from 10 April 2024 to 9 April 2025)
- the ability to supply (as an approved source) dogs six months of age or older, and cats eight weeks of age or older, to pet shops to enhance foster animal exposure and rehoming opportunities.

If approval is granted to join the scheme, your local council will issue you with a certificate that you will need to show if you intend to supply pet shops, to demonstrate that you are an approved source eligible to supply cats and dogs.
