22.14 STUDENT ACCOMMODATION POLICY

This policy applies to all planning permit applications for <u>use or development of student</u> accommodation in the City of Whitehorse <u>intended to house students undertaking tertiary</u> <u>study</u>. All facilities that provide accommodation for students are encouraged to comply with the standards in this policy.

Student accommodation can be either informal or purpose built. Informal student accommodation involves students occupying dwellings (shared housing), as defined within the planning scheme, that have not been specifically built as student accommodation. Dwellings can be used by students for shared housing ete at times without the need for a planning permit.

Purpose built student accommodation is accommodation that is specifically built for occupation by students having regard to their specific needs. If the accommodation comprises fully self contained units that meet the definition of a dwelling, and satisfy all the associated requirements in the planning scheme, a planning permit may not be required for the use, but a planning permit will still be required for the construction of buildings and works. A permit may also be required for a reduction in standard car parking requirements if located in a business zone or other zone to which Clause 55 does not apply.

If a student accommodation development does not comprise fully self-contained apartments that come within the definition of a dwelling, the use will be defined as a residential building and a planning permit will be required for the use, as well as for the construction of the buildings and works. A permit may also be required for a reduction in standard car parking requirements if located in a business zone or other zone to which Clause 55 does not apply

This policy must be read in conjunction with the following local policies:

- The Residential Development Policy at Clause 22.03.
- The Tree Conservation Policy at Clause 22.04.
- The Activity Centres Policy at Clause 22.06.
- The Box Hill Activity Centre Policy at Clause 22.07.

The City of Whitehorse is home to two major tertiary education facilities: Box Hill Institute of TAFE in Elgar and Whitehorse Roads, Box Hill, and Deakin University on Burwood Highway, Burwood. These institutions have created education precincts with thriving growing student populations. With a dramatic increase in international student enrolment over the last 10 years, demand for student accommodation has lead to a considerable number of planning permit applications for a range of different types of student accommodation in Whitehorse. The demand for purpose built student accommodation is anticipated to continue into the future.

Student accommodation is provided in different typologies in Whitehorse. These include:

- On campus residential colleges;
- Purpose built student accommodation which can be provided in residential buildings, a residential village, group accommodation or in apartments;
- Boarding houses including rooming houses;
- Open market housing, such as dwellings which may be shared housing; and
- Informal housing including garages, outbuildings or structures unlawfully converted to housing.

With the exception of purpose built accommodation, student accommodation will generally not trigger the need for a planning permit. In these instances this policy does not apply, however student accommodation is encouraged to comply with this policy.

This policy applies to accommodation that has specifically been developed for the accommodation of students that are undertaking tertiary study.

Council supports student accommodation that provides convenient access to tertiary education institutions and easy access to a wide range of shops, restaurants, financial, social, entertainment and leisure facilities, and to public transport.

The preferred locations for student accommodation facilities are on campus or within 500m of a tertiary education institution, within a Metropolitan or Major Activity Centre or along the Principal Public Transport Network (PPTN).

There are a range of elements where students have special requirements that warrant variation to normal standards. These include:

- Car parking requirements, as student car parking needs can be very low in student accommodation that is well located to tertiary facilities, public transport and activity centres.
- Communal spaces to facilitate socialising and reduce social isolation and to promote high quality design and more efficient use of space. This may include shared kitchens, bathroom facilities, laundry facilities and recreational living areas.
- Private open space as student socialising is often done outside the home.
- Storage requirements, which can be low due to the transient nature of the student population

The impact of purpose built student accommodation on the character and amenity of residential areas has raised concerns. Aspects of Clauses 19 and 55 that relate to neighbourhood character and infrastructure, site layout and building massing, and off-site amenity impacts, remain relevant to proposals for student accommodation within the residential areas of Whitehorse. Some aspects of Clause 55 are less relevant to student accommodation because of the specific needs of students. These include car parking, private open space and storage requirements. This policy will provide guidance in relation to these and other matters.

The needs of students is a particular focus of this policy. Students have different needs to many other residents. There are also additional matters that need to be taken into consideration in the design of student accommodation that are not relevant to other types of dwellings. Much purpose built student accommodation is occupied by international students. Domestic students are more likely to occupy informal types of student accommodation such as shared housing. Regard also needs to be given to the fact that students may be living away from family and friends, in an unfamiliar culture, and subject to considerable pressure as a result of their students, expectations, the high cost of studying overseas and isolation.

It is important that in addition to the practical needs of students, the social and emotional needs of students are considered in locating and in designing appropriate purpose built student accommodation facilities.

From a location perspective, convenient access to their respective education institution, and easy access to a wide range of shops, restaurants, financial, social, entertainment and leisure facilities and public transport is particularly important. Locations in or close to their institutions, that are within major, principal and specialised activity centres, or within 500 metres of a tertiary education institution or along the Principal Public Transport Network are the preferred locations for student accommodation facilities.

From a design perspective, it is important to provide a facility that is supportive of students' practical, social and emotional needs. Students need a quiet and studious environment, but also one that provides a collegiate atmosphere with the opportunity for students to meet with others and to avoid social isolation and exclusion. Students generally require a bright and well lit room, with either sufficient space to cook, meet, eat, and socialise, or smaller rooms designed to accommodate sleep and study with the provision of shared or communal areas and facilities that provide for these needs. Safety, security and affordability are also particularly important considerations.

Many of the modified requirements associated with student accommodation, for example reduction in car parking, private open space and a smaller room sizes, can only be justified when student accommodation_is of exemplary design and responds well to the needs of students in other ways such as high quality purpose built communal spaces. well located within identified preferred locations. Support for reduced car parking requirements may be

becomes less justified where student accommodation is well located and within preferred locations, but becomes less justified as the distance from preferred locations increases.

To conveniently and appropriately locate student accommodation.

To ensure the design of new student accommodation does not degrade privacy and amenity of abutting residential land uses and respects the existing or preferred character of the area. To provide appropriate car<u>and bicycle</u> parking.

To create facilities that enhance the safety and amenity of abutting streets and the neighbourhood.

To ensure that the design of new student accommodation demonstrates flexibility for future adaptation to alternative uses.

To encourage practical landscape solutions that complement the design of open space areas and respond to the valued character of the neighbourhood.

To ensure new student accommodation embodies principles of good urban design, sustainability, affordability and durability.

To provide shared communal spaces that contribute to the functioning and amenity of student accommodation and promote interaction between students.

Demand for student accommodation

 Applications should describe how provision of the student accommodationresponds to market demand and student needs.

Section 173 Agreement

- Any planning permit issued for the use or development of student accommodation or for a waiver or reduction of car parking associated with a student accommodation use, will-include a condition that the owner enter into an agreement under sSection 173 of the *Planning and Environment Act 1987* requiring that the development<u>or</u> <u>defined part of a development</u> can only be used for the purpose of student accommodation. This will include a requirement for an appropriate management plan to be prepared.
- Landowners must enter into an agreement with the responsible authority under Section 173 of the Planning and Environment Act 1987 that includes the following:
 - A requirement that the development can only be used for the purpose of student accommodation.
 - Car spaces must be associated with the use of of student accommodation and must not be subdivided, sold or used separately from the student accommodation.
 - The number of students residing on site who own cars must not exceed the number of on-site car spaces provided by the development.
 - A requirement that the use must be managed in accordance with an approved Management Plan referred to below.
- The owners of the land to be developed or used as student accommodation must pay all the responsible authority's legal costs and expenses of the Section 173 Agreement, including preparation, execution and registration on title.

Location

- It is policy that:
- Student accommodation can be supported The preferred location for new student accommodation is:
 - Within a Principal Metropolitan or-Major Activity Centre.
 - On sites that are within 500 metres of a tertiary education institution.
 - On sites abutting the Principal Public Transport Network.
- Student accommodation is <u>discouraged not supported not supported in minimal</u> change areas as designated in the residential development policy at Clause 22.03.

Built form and assessment

It is policy that:

- In the General Residential Zone and parts of the Mixed Use Zone designated as natural change in Clause 22.03:
 - Proposals will be assessed using the residential development policy contained in Clause 22.03 and Clause 55. Clause 55 Sstandards may be reduced for in relation to those elements of Clause 55 that relate to car parking, private open space and storage where it meets this policy.
 - Clause 52.06 requirements may be reduced for car parking in accordance with the rates in this policy.
- Buildings are encouraged to be one to two storeys.
- Buildings of four storeys or more will not be supported.
- In the Residential Growth Zone and parts of the Mixed Use Zone identified as substantial change in Clause 22.03:
 - <u>Clause 55 and Clause 58 standards may be reduced for private open space</u> and storage where it meets this policy.
 - <u>Clause 52.06 requirements may be reduced for car parking in accordance</u> with rates in this policy.

- Proposals of up to four storeys will be assessed against the residential development policy contained in Clause 22.03 and Clause 55. Standards may be reduced in relation to those elements of Clause 55 that relate to car parking, private open space and storage.
- Proposals of five storeys or more will be assessed using the urban design principles contained in Clause 19.03, the Design Guidelines for Higher Density Residential Development, Clause 22.03, and Clause 52.35.
- Proposals must be consistent with any structure plan or other strategic work prepared for a Substantial Change Area.

Proposals in a business zone within a principal or major activity centre, in addition to this policy, may be assessed using the principles contained in Clause 19.03, the Design Guidelines for Higher Density Residential Development, Clause 52.35 and the Activity Centre Design Guidelines.

Proposals of four storeys or more may be appropriate in a business zones and within a principal or major activity centre, depending on the location within the zone, abuttals to other uses and to other zones, and any structure plan prepared for those zones or activity centres.

Car parking

It is policy to:

- Encourage the provision of eCar parking be provided in accordance with the needs of students. Council will consider the special circumstances of each proposal on its merits. The following requirements apply:
 - Generally:
 - For <u>purpose built student accommodation</u> developments designed as residential buildings (student accommodation) within a principal <u>Metropolitan aActivity eCentre</u>, provide car parking at a rate of at least 0.1, spaces per bed.
 - For purpose built student accommodation developments designed as residential buildings (student accommodation) within mMajor or specialised aActivity eCentres, within 500 metres of a tertiary education institution or on a site abutting the Principal Public Transport Network, provide car parking at a rate of at least 0.25 spaces per bed.
 - Allowance should be made for visitor parking on site having regard to clause 52.06. Car parking spaces allocated as visitor spaces should be on common property.
 - A higher rate of car parking will be required as the distance from the preferred locations increases.

Bicycle parking

It is policy to:

- The following requirements apply to the provision of bicycle parking:
 - <u>Provide</u> Ensure the provision of adequate areas for short term (visitor) and secure long term (resident) bicycle storage.
 - Provide <u>at least</u> one long term (resident) bicycle parking space per 3 beds.
 - Bicycle parking and storage areas should be on common property and easily accessible.

Street safety and amenity

It is policy to:

- Ensure the creation of an attractive interface of habitable rooms, balconies and terraces with adjacent street frontages.
- Encourage active ground floor uses such as retail shops or entry lobbies along the street perimeter in business and mixed use zones.

- Promote personal safety in public spaces in the daytime and evening through the organising of units so they provide visual surveillance of those spaces.
- Encourage the creation of clear physical and visual links to entries from the street.

Flexibility for future adaptationBuilding design

It is policy to:

- Design of student accommodation buildings should be adaptable Encourage, where
 appropriate and practicable, buildings that are adaptable in their future for
 future
 use by other uses with low car parking demands.
- Architectural and cladding finishes should be of high quality presentation.
- Building design should provide an active interface to the street.
- Building design should provide clear physical and visual links to entries from the street.
- Ecologically sustainable landscaping should form an integral part of the design solution.

Landscape and streetscapes

It is policy to:

- Ensure that sustainable landscaping is an integral part of the design solution.
- Encourage the creation of high quality private and shared open spaces.
- Encourage the permeability of external ground surfaces.
- Ensure that exposed at grade car parking is minimised.
- Ensure new setbacks incorporate canopy screening trees or equivalent screening protection where trees characterise boundary abutments.

Design and sustainability

It is policy to:

- Require major proposals to submit an Environmentally Sustainable Design plan.
- Facility Sharing

It is policy to:

 Encourage the sharing of facilities, amenities and open space between educational providers and new student accommodation through reductions in requirements for shared recreational and study space where they are demonstrably within easy walking distance of the institution.

Meeting the needs of tertiary students

It is policy to:

- Council supports stdent accommodation that provides self-contained units each accommodating one student (with an individual bathroom) but will consider student accommodation that provides shared rooms (more than one student), or shared bathroom facilities where:
 - <u>All other elements of this policy are met;</u>
 - <u>A mix of accommodation choices are provided in the student</u> accommodation; and
 - Student affordability objectives can be achieved.
- Require the following facilities in each unit: Facilities within each student accommodation unit must:
 - A minimum of 16 square metres floor area.
 - <u>Contain a A bathroom with shower, hand basin and WCtoilet (unless</u> <u>Council is supportive of a shared facility arrangement).</u>
 - Include a A separate sleeping area separated from the living room.

- <u>Include a robe /drawer unit for storage of clothing and personal items for each student</u>.
- Include linternet and TV connection and power points.
- Require the provision of <u>Have</u> direct natural light and ventilation to living / bedrooms in the form of openable windows.
- Encourage Require provision of access to areas of Provide direct access to private open space such as a small balconette or terrace, a minimum of 8 square metres (with a width of 2m) in area for each unit unless appropriate shared or communal spaces are provided to an acceptable standard.
- Where possible, circulation spaces have natural light and ventilation.
- Encourage the provision of a <u>A</u> range of room types is supported in each development, including bed-sitters, one bedroom <u>units</u>, a two bedroom unit and where possible provide at least one <u>unit to accommodate students with a disability</u>. disabled unit and one two bedroom unit.

Shared spaces for interaction between students

It is policy to:

- Encourage the provision of communal areas such as indoor spaces, ground level open space, balconies or terraces to the street, or rooftop zones. The following shared spaces be provided:
 - Kitchen facilities with adequate provision of stovetops, ovens, microwaves, sinks, fridges, dishwashers and food preparation areas (unless Council is supportive of cooking facilities in each unit).
 - Communal areas such as indoor spaces, ground level open space, balconies or terraces to the street or useable rooftop areas.
 - Encourage the provision of fFoyers and mail collection areas.
 - Encourage the provision of sStorage lockers in a central location.
 - Encourage the provision of 1Laundry, washing and drying facilities.

- In assessing applications the responsible authority will consider:
 - How the use or development responds to the demand and range of student accommodation in Whitehorse.
 - The extent to which the use and development meets the objectives and requirements of this policy.
 - The location of the use or development. Whether the use and development is appropriately located in relation to the preferred locations as nominated in this policy.
 - The potential of the proposal to ensure a safe, pleasant environment for students and to minimise negative off-site impacts.
 - Whether the development meets the needs of various categories of students.
 - Whether the design and built form of the development meets the objectives relating to personal safety included in the Safer Design Guidelines for Victoria and the Design Guidelines for Higher Density Residential Development.
 - Whether the development includes the provision of communal areas that promote social interaction, for instance through <u>design of open space</u>, <u>landscaping and</u> common rooms-and open spaces.
 - Whether the development is sustainable.

- Whether the development has been designed in a sustainable way so that it reduces the negative impacts on the environment.
- Whether there is adequate car parking and bicycle parking provision.
- Any traffic impacts.
- The ability of the development to be easily converted to other uses in the future, if
 demand for student accommodation declines.
